## **SCHEDULE OF CHARGES FOR NEW WORKS**

## Levied with effect from 1 January 2024

Under the provisions of Section 33 of the Milford Haven Conservancy Act 1983

CLASS A WORKS Which include berthing heads, landing stages, pontoons and works of any description for berthing vessels alongside or for the purpose of landing persons or goods:	£ pa
For the first 10 metres or part of 10 metres of the length of berthing face	2,291
For each additional metre or part of a metre by which the sum of the length of the sides of the works which are available for berthing vessels alongside or for the purpose of landing persons or goods exceeds 10 metres	77
For each vessel which is or may at any one time be berthed or moored at the works in excess of one vessel	123
CLASS B WORKS Which include dolphins, piles and works of any description for the mooring of vessels other than Class A Works:	
For berths for vessels not exceeding 15 metres in length overall	4,579
In respect of each additional vessel which is berthed there at any one time in excess of 3 vessels	123
For berths for vessels exceeding 15 metres in length overall but not exceeding 30 metres in length overall	9,157
In respect of each additional vessel which is berthed there at any one time in excess of 3 vessels	229
For berths for vessels exceeding 30 metres in length overall	18,315
In respect of each additional vessel which is berthed there at any one time in excess of 3 vessels	3,816

CLASS C WORKS  Being works of any description used for the slipping of vessels:	
being works of any description ascallor the suppling of vessels.	
<ul> <li>(i) Private Slipways</li> <li>(ii) being slipways not exceeding 3 metres in width, built by private persons for their personal use by their own vessels used wholly for recreation and not used by the general public or by a person operating the slipway or any land works or buildings reached by the slipway for profit or by any club or boat association or the like:</li> </ul>	
For a slipway not more than 500mm above the level of the seabed	229
For each 100mm or part of 100mm in excess of 500mm above the level of the seabed	77
(ii) Common User Slipways being all slipways other than private slipways:	
For a slipway not exceeding 4 metres in width and not more than 500mm above the level of the seabed	763
For each 100mm or part of 100mm in excess of 500mm above the level of the seabed	77
For each metre or part of a metre in excess of 4 metres width, an additional 10% of the charges otherwise payable	
CLASS D WORKS Being any other small works (ie. Drainage Water Outfall etc)	763
CLASS E WORKS  Being any other major works transiting all or part of the Haven (ie. pipeline or offshore installation etc), subject to a minimum charge of £2,290 pa	£48 per linear metre pa or £2.50 per sq metre pa
