 - The Trust Port of Milford Haven must do more to maintain our built and maritime heritage, whether that's protecting historic buildings and facilities in the dockyards and waterway as well as the community that rely on those facilities being available and NOT kowtowing to external influences whose only interests are profit based. The Milford Haven Waterway is the historic jewel in Pembrokeshire's crown, but there is a genuine unease in the communities I am involved with as it feels that the Port Authority do not have the local stakeholder community's interest at heart when it deals with external organisations looking to develop and profit from facilities on the waterway. Instead of being the portal to the community to help develop services by the community for the community it appears that the Authority actively blocks or under resources other stakeholder organisations in order to make way for its own, often hidden agenda. The change of status away from a Trust Port and the development of a marina at Pembroke Dock are cases in point. IF the Authority is genuinely looking to be the part of our community that it says it wants to be, it should seriously review its hankering to change its status from a Trust Port. How could the local community have any faith in a body that is only profit focused - It could only represent its shareholders and not its stakeholders. Pembroke Dock Marina is a great idea and would be a brilliant addition for the locals who struggle for mooring space on the waterway. Yet it seems that instead of looking to develop services for the local community the plans were aimed at getting a narrow sector of boat owners from out of the county who rarely make use of the waterway a nice place to have holiday flats and some shops that would further add to the decline of the towns existing shopping street. The West Wales Maritime Heritage Society, possibly the best placed users of the HISTORIC Hancock's Front Street dock yard are to be relocated to allow for this site to be developed and access to the 3 public slipways would become restricted and a possible launching fees being applied.
