1986 CHAPTER XX

An Act to alter the name of the Milford Haven Conservancy Board and to extend the power to make payments to members. [7th November 1986]

WHEREAS-

"" (1) By the Milford Haven Conservancy Act 1958 the Milford Haven Conservancy Board were established and charged with the duty of taking such steps as the Board may from time to time consider necessary or expedient to maintain, improve, protect and regulate the navigation and in particular the deep-water facilities in an area therein defined: 1958 c. 23.

(2) By various subsequent Orders and by the Milford Haven Conservancy Act 1975 the powers and duties of the Board were amended and extended and the area in respect of which the functions of the Board are discharged was extended: 1975 c. xxviii,

(3) By the Milford Haven Conservancy Act 1983 the provisions of the various enactments by which, or by reference to which the constitution, powers, rights, authorities, privileges, duties and obligations of the Board were then defined, were consolidated with amendments: 1983 c. xix.

(4) It is expedient that the name of the Board be altered to "the Milford Haven Port Authority":

(5) It is expedient that the other provisions in this Act be enacted:

(6) The purposes of this Act cannot be effected without the authority of Parliament:

May it therefore please Your Majesty that it may be enacted, and be it enacted, by the Queen's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same, as follows:-

- Short title.           **1.** This Act may be cited as the Milford Haven Port Authority Act 1986.
- Change of name.       **2.**-(1) As from 1st January 1987 the Milford Haven Conservancy Board shall be renamed the Milford Haven Port Authority.
- (2) Any reference in any enactment or other document to the Milford Haven Conservancy Board shall from 1st January 1987 be construed as a reference to the Milford Haven Port Authority.
- Payment to members. 1983c.xix.           **3.** For paragraph 19 of Schedule 1 to the Milford Haven Conservancy Act 1983 there shall be substituted-
- " 19. The Board may, with the agreement of any member, pay to him or to his employer or to a body after consultation with which he has been appointed a member such salaries, fees, allowances and other expenses as the Board may from time to time determine:
- Provided that- :-
- (a) no payment may be made under this paragraph to an employee of the Board; and
- (b) no salary or fee may be paid to any member of the Board (other than the chairman and vice chairman) exceeding £1 000 or that sum increased by an amount which bears the same proportion to the said sum of £1 000 as shall be borne by any increase in the Index of Retail Prices to the figure shown therein for the month of November 1985, and for that purpose 'the Index of Retail Prices' shall mean the Index of Retail Prices published by H.M. Stationery Office or any official publication substituted therefor."
